Messages from Environment Sustainability Team The British Council

The Environment team in the UK leads the British Council's embedding of sustainability by managing its environmental impacts with the support of colleagues across the global network. The Environmental Framework Tool (EFT) was developed in 2008 as guidance to support best practice in environmental management in our 110 overseas offices.

The 5-level framework gives the flexibility required to manage environmental impacts in very different operating contexts, but to a globally consistent approach. The EFT achieved recognition at the 2010 London Mayor's Green500 awards with a commendation in the Special Awards in the indirect leader category. The current corporate target for EFT is level 4 by 31 March 2014; 60% have achieved level 3 to date. EFT level 4, consisting of a regional environmental action plan, is now being implemented with all overseas regions.

Colleagues in Pakistan achieved levels 1 to 3 in just five months towards the end of 2013 and are now working with colleagues across the South Asia region to develop their environmental action plan. Our colleagues in Pakistan continue to show tremendous commitment to reducing the environmental impact of their buildings and activities.

Their carbon footprint is measured and monitored year-on-year which enables them to identify and introduce initiatives to tackle areas of significant impact, such as water use and staff travel. Forthcoming office refurbishments offer the opportunity to implement further initiatives to reduce the impact of their buildings.

Environmental Policy

The British Council creates international opportunities for the people of the UK and other countries and builds trust between them worldwide. We do this through our work in three "strategic business areas"

- Education and Society
- English
- Arts

We recognise that our activities impact on the environment and are committed to minimising this by improving our environmental performance. We will do this by setting and reviewing objectives and targets as set out in the British Council's Environmental Framework Tool. We commit to minimising our environmental impact by:

- Understanding and measuring of environmental impacts arising from our activities.
- Ensuring that we understand and comply with all legal obligations under the Pakistan Environmental Protection Act (PEPA-1997), together with all other applicable statutory provisions and relevant codes of practice.
- Setting environmental objectives and targets for activities with significant impact, mindful of the aspirations of our partners.
- Minimise energy and water usage in our buildings, vehicles and processes in order to conserve supplies, and minimise our consumption of natural resources, especially where they are non-renewable. Minimise the generation of waste and implement re-use or recycling initiatives wherever possible;
- Ensuring that our policy is understood, implemented and maintained by everyone in the organisation and supported by appropriate training of the staff.
- Communicating our progress in reducing our environmental impact to internal and external stakeholders.
- Reviewing and maintaining this policy to reflect changes in the organisation, government targets or significant external factors.

Our current focus is:

- To ensure the growth of our organisation is sustainable and that the environmental impacts of our work are assessed alongside social and economic considerations
- To reduce our consumption of energy and water, and the resulting carbon emissions
- To reduce waste by embedding of waste hierarchy of 'reduce, re-use and recycle"
- To use sustainable options when procuring goods and services
- To monitor and reduce the environmental impact of our business travel and explore innovative mechanisms to continue to deliver our cultural relations work effectively
- To use our creative skills and strengths as a global organisation to promote sustainability with climate change agenda and incorporating sustainable development themes across our portfolio of activity.

Sustainable Procurement Policy

The British Council aims to purchase goods in a way which minimises the impact on the environment by:

a) Minimising the amount we purchase (only purchasing goods which are necessary for the successful delivery of services)


b) Striving to ensure that the environmental impact of production, transportation, use and disposal is minimised for all purchases.

The British Council will strive to assess and minimise the environmental impacts of the following when making a purchase specifically:-

- Energy consumed in production and use of the goods
- Water consumed in the production and use of the goods
- Waste disposal issues including the opportunities for re-use and recycle and the possibility of pollution/contamination associated with disposal
- Transportation associated with the good
- The scarcity and source of the raw materials used for the goods (including the impact on wildlife and their habitats and the landscape)

The British Council aims to ensure contractors/suppliers adopt environmental standards which are at least as good as ours and which reflect recognised environmental best practice.

All contractors/suppliers must agree to comply with all environmental issues contained within the Environment Framework Tool documentation when delivering a service on the British Council property.




Solid Waste Management

The British Council Pakistan supports the implementation of integrated solid waste management systems within our office premises and encourages our employees for recycling and reusing.


- In the Cafeteria's of the British Council following colour coded/labelled waste bins have been placed
- 1. Green for Plastic
- 2. Blue for Paper
- 3. Red for Glass
- 4. Yellow for Metals/batteries/phones
- 5. Grey for Food and Garden Waste (Fruit peels, organic waste)
- 6. White for Disposables
- Waste bins for rest rooms disposed off daily.
- In each room, an accessible paper recycling bins placed.
- An external vendor hired to collect all the recyclables that includes paper, plastic, metal and glass on a monthly basis.
- EFT Team maintaining an electronic register about data of weight and type of solid waste
- All support staff must wear Personal Protective Equipment' (PPEs) during dusting and cleaning.
- Garden and Food Waste used for composting where area is available.
- Training is given to support staff on a quarterly basis. For motivation of support staff some incentive based plan could be devised.
- All employees put waste/scrap paper in waste bins.
- Important office documents like contracts shredded before handing over to vendor for recycling.
- Littering is strictly prohibited in office premises.






































Environmental Awareness






3. The Worst Environmental Problem Facing the Planet






6. Awareness of Environmental Laws of Pakistan


7. Rate Environmental Conservation Practices in British Council Pakistan


8. Willingness to Participate in Environmental Awareness Activities and Trainings


9. Knowledge about EFT and its implementation up-till now


10. Frequency of Visits of Country Intranet Green pages


11. Encouragement of fellow colleagues to adopt environment friendly measures


12. Promotion of environmental friendly measures like recycling, energy conservation etc at your home

Social Action Projects on Environment

Environmentalism is an ideology that evokes the necessity and responsibility of humans to respect, protect, and preserve the natural world from its anthropogenic afflictions. Awareness of climate change and other environmental concerns has increased in the last few decades . However, there is still a lot of work to be done to increase public awareness, particularly in underdeveloped countries like Pakistan.

According to UNEP, environmental awareness campaigns are most successful when targeted to specific groups or populations. Environmental education is very important in the developing world as it is in industrialised nations; however, reaching out to the people in those countries can be very difficult.

Language barriers, illiteracy, and cultural differences can prevent them from learning about environmental issues, particularly in rural or tribal areas. Reaching out to tribal, religious, and community leaders can often help a government organisation or non-governmental organisation (NGO) educate the people on environmental issues. Community leaders can help ease communication problems and bridge the cultural divide that often stands in the way of outreach efforts.

British Council Pakistan under their program of "Active Citizen Pakistan" have lead more than 400 social action projects with over 30,000 beneficiaries on environment / health were conducted in the year 2012-2013. These projects have been on diversified environmental issues like from cleaning streets to planting trees to creating awareness about clean healthy environment etc.

Way Forward

In 2014 we will:

- Develop Scrutinised and centralised implemented system for Carbon Footprint in all three offices.
- Develop the Automatic Carbon footprint Display
- Collaborate with government agencies for spreading the environmental message on a massive level
- Develop Environmental Questionnaires for HR induction/ appraisals system
- Develop of Strategic Partnerships with other green organisations like IUCN, WWF etc.
- Develop and Implement Sustainable Travel and Transport Policy
- Develop and Establish of frequency Internal/External Environmental Audits
- Organise awareness and behavior change sessions for green practices in all offices of the British Council Pakistan
