Criteria:

The criteria for having the names of your students and institute published on British Council's website are as below;

- a. Achievement of 6.5 or higher in IELTS Test with the British Council
- b. Test taken with British Council in the last three months only.
- c. Your institute needs to have been an IELTS partner institute for at least 12 months and should have registered candidates with British Council through B2B portal in line with your institute's partnership status.
- d. In case of multiple entries, British Council reserves the right to publish select few on its media channels.
