2 Introduction and Background to the Project / Programme

2.1 The British Council is implementing a project titled 'PAK UK Education Gateway' in Pakistan to enhance partnership between the higher education sectors of Pakistan and the UK. Under the project, the British Council is commissioning a baseline and need assessment study to strengthen STEM education in Pakistan.

STEM (Science, Technology, Engineering, and Mathematics) education is a critical driver of innovation, economic growth, and societal advancement in the 21st century. Global leaders in STEM education, such as Finland, Singapore, and South Korea, have successfully aligned their academic programs with labor market demands, fostering innovation and producing a highly skilled workforce.

In Pakistan, however, the higher education sector faces systemic challenges. Outdated curricula, skill mismatches, limited experiential learning, and weak academia-industry collaboration have led to low employability rates among graduates. These issues underscore the urgent need for reforms to align STEM education with labor market requirements and national development goals, as articulated in the "Uraan Pakistan" framework. https://uraanpakistan.pk/

This baseline and need assessment study aims to establish benchmarks to subsequent address these challenges. The study shall generate evidence-based insights to inform strategic reforms, ensuring that STEM education contributes to Pakistan's socio-economic progress.

The British Council is seeking proposals from qualified and experienced local and international research institutions, consulting firms, consortium or individual consultants with a strong track record in conducting baseline studies and need assessments, particularly within the education and development sectors at national and international level.

2.2 The purpose and scope of this RFP and supporting documents is to explain in further detail the requirements of the British Council and the process for submitting a proposal in response to this RFP ("**Proposal**").

3 Proposal Conditions and Contractual Requirements

This section of the RFP sets out the British Council's contracting requirements, general policy requirements, and the general conditions relating to this procurement process ("**Procurement Process**").

3.1 Contracting requirements

- 3.1.2 <u>Delivery location for goods and/or services</u>: The Services will be required across Pakistan.
- 3.1.3 <u>Duration</u>: 6 months with an option for an extension for up to an additional 3 months based on performance.
- 3.1.4 <u>Contractual terms</u>: As_set out at Annex 1 Insert [(Terms and Conditions of Contract ("**Contract**"). By submitting a Proposal, you are agreeing to be bound by the terms of this RFP and the Contract without further negotiation or amendment. In the event that the chosen service provider is operating as a Sole Trader or through a Personal Service Company, the British Council retain the right to issue specific contractual terms and conditions, in order to take account of this status. If you plan to submit a bid as a Sole Trader or Personal Service Company please contact at moiz.khalid@britishcouncil.org / https://tap.tcsapps.com/tap2/#/bc-supplier-registration for a copy of the specific terms. Once the Contract is awarded, there will be no changes allowed to the Contract (except in accordance with the provisions of the Contract). Any clarification questions in relation to any aspect of this Procurement Process and the

associated documentation should be submitted in accordance with the process set out in paragraph 12 (*Clarification Requests*). Only changes which relate to the correction of ambiguity or manifest error in relation to the terms of the Contract will be considered and, if necessary, the British Council may, when issuing its response to clarification questions, reissue Annex 1 to reflect such changes. Any proposed amendments received from a potential supplier as part of its Proposal shall entitle the British Council to reject that Proposal and to disgualify that potential supplier from this Procurement Process.

3.2 General Policy Requirements

3.2.1 By submitting a Proposal, you confirm that you will, and that you will ensure that any consortium members and/or subcontractors will, comply with all applicable laws, codes of practice, statutory guidance and applicable British Council policies relevant to the goods and/or services being supplied. 3.3 General Proposal conditions ("Proposal Conditions")

- 3.3.1 <u>Application of these Proposal Conditions</u> In participating in this Procurement Process and/or by submitting a Proposal it will be implied that you accept and will be bound by all the provisions of this RFP and its Annexes. Accordingly, Proposals should be made on the basis of and strictly in accordance with the requirements of this RFP.
- 3.3.2 <u>Third party verifications</u> Your Proposal is submitted on the basis that you consent to the British Council carrying out all necessary actions to verify the information that you have provided, and the analysis of your Proposal being undertaken by one or more third parties commissioned by the British Council for such purposes.

- 3.3.4 <u>Potential suppliers to make their own enquires</u> You are responsible for analysing and reviewing all information provided to you as part of this Procurement Process and for forming your own opinions and seeking advice as you consider appropriate. The clarification process set out in paragraph 12 should be used for any queries in relation to this Procurement Process.
- 3.3.5 <u>Amendments to the RFP</u> At any time prior to the Response Deadline, the British Council may amend the RFP and if appropriate, the Response Deadline shall, at the discretion of the British Council, be extended.

- 3.3.6 <u>Compliance of Proposal</u> Any goods and/or services offered should be on the basis of and strictly in accordance with the RFP (including, without limitation, any specification of the British Council's requirements, these Proposal Conditions and the Contract) and all other documents and any clarifications or updates issued by the British Council as part of this Procurement Process.
- 3.3.7 <u>Compliance with the terms of the Contract</u> The successful supplier must comply with the Contract as set out in Annex 1 without any amendment (save as described in paragraph 3.1.4).
- 3.3.8 <u>Format of Proposal</u> Proposals must comprise the relevant documents as detailed by the British Council in Annex 2 (Supplier Proposal) completed in accordance with relevant all instructions. Any documents requested by the British Council must be completed in full. It is important that you read the RFP carefully before completing and submitting your Proposal.
- 3.3.9 <u>Modifications to Proposals once submitted</u> You may modify your Proposal prior to the Response Deadline by giving written notice to the British Council. Any modification should be clear and submitted as a completely new Proposal in accordance with Annex 2 (Supplier Proposal) and these Proposal Conditions.
- 3.3.10 <u>Disqualification</u> If you breach these Proposal Conditions, if there are any errors, omissions or material adverse changes relating to any information supplied by you at any stage in this Procurement Process, if any other circumstances set out in this RFP, and/or in any supporting documents, entitling the British Council to reject a Proposal apply and/or if you or your appointed advisers attempt:
 - to inappropriately influence this Procurement Process or fix or set the price for goods or services;
 - to enter into an arrangement with any other party that such party shall refrain from submitting a Proposal;
 - to enter into any arrangement with any other party (other than another party that forms part of your consortium bid or is your proposed sub-contractor) as to the prices submitted;
 - to collude in any other way;
 - to engage in direct or indirect bribery or canvassing by you or your appointed advisers in relation to this Procurement Process: or
 - to obtain information from any of the employees, agents or advisors of the British Council concerning this Procurement Process (other than as set out in these Proposal Conditions) or from another potential supplier or another Proposal.

- 3.3.12 <u>Rights to cancel or vary this Procurement Process</u> Nothing in this Procurement Process will bind the British Council to enter into any contractual or other arrangement with you or any other potential supplier. It is intended that the remainder of this Procurement Process will take place in accordance with the provisions of this RFP, but the British Council reserves the right to terminate, amend or vary (to include, without limitation, in relation to any timescales or deadlines) this Procurement Process by notice in writing. Subject to the "Liability" Tender Condition below, the British will have no liability for any losses, costs or expenses you incur as a result of such actions.
- 3.3.13 <u>Consortium Members and sub-contractors</u> It is your responsibility to ensure that any staff, consortium members, sub-contractors and advisers abide by these Proposal Conditions and the requirements of this RFP.

- 4.1 All information supplied to you by the British Council, including this RFP and all other documents relating to this Procurement Process, either in writing or orally, must be treated in confidence and not disclosed to any third party (save to your professional advisers, consortium members and/or subcontractors strictly for the purposes only of helping you to participate in this Procurement Process and/or prepare your Proposal) unless the information is already in the public domain or is required to be disclosed under any applicable laws.
- 4.2 You shall not disclose, copy or reproduce any of the information supplied to you as part of this Procurement Process other than for the purposes of preparing and submitting a Proposal. There must be no publicity by you regarding the Procurement Process or the future award of any contract unless the British Council has given express written consent to the relevant communication.
- 4.3 The British Council reserves the right to disclose all documents relating to this Procurement Process, including without limitation your Proposal, to any employee, third party agent, adviser or other third party involved in the Procurement Process in support of, and/or in collaboration with, the British Council. The British Council further reserves the right to publish the Contract once awarded and/or disclose information in connection with supplier performance under the Contract in accordance with any public sector transparency policies (as referred to below). By participating in this Procurement Process, you agree to such disclosure and/or publication by the British Council in accordance with such rights reserved by it under this paragraph.

5.1 Your Proposal must remain open for acceptance by the British Council for a period of sixty days from the Response Deadline. A Proposal not valid for this period may be rejected by the British Council.

- 6.1 The British Council will pay correctly addressed and undisputed invoices within 30 days in accordance with the requirements of the Contract. Suppliers to the British Council must ensure comparable payment provisions apply to the payment of their sub-contractors and the sub-contractors of their sub-contractors. 7 Specification

The overarching goal of this study is to evaluate the current state of STEM education in Pakistan, identify gaps, and propose strategic reforms to enhance employability and innovation. Specific objectives include:

Objective	Description	
Current State Analysis	Assess the current state of STEM education in Pakistan in terms of curriculum quality, teaching practices, capacity of the faculty across educational institutions, compatible infrastructure, and accessibility of resources and services (both for teachers and students)?	
Benchmarking	Where does Pakistan's STEM education stands in comparison with regional and global benchmarks/standards, and what lessons/best practices can be drawn from successful international models, to design impactful programmes in space of Pakistan and for policy insight as well?	
Gap Analysis	Identify the key gaps between STEM education academic offer and the labour market needs, identify what barriers preferably skill mismatches, infrastructure, and challenges to towards employability are prevalent?	

Trend Analysis	What emerging trends in STEM (globally) are shaping future skill requirements, and how can Pakistan's system adapt to prepare students for these future demands? Assess to how much extent the current STEM graduate is ready to meet industry requirements.
	 Identify the contemporary trends as well the ones near to obsolete and needs replacement especially in space of Pakistan.
State of industry academia linkages	To what extent currently the industry and academia, along with stakeholders are collaborating in curriculum design, research, and employability pathways. The consultant or research team will undertake a comprehensive baseline and need assessment study to evaluate the state of STEM education in Pakistan and its alignment with labor market needs. As part of this assignment, it is expected to draw analyses using problem tree (to map root causes and effects) and solution trees (to identify practical pathways for improvement) at the end of each area analysis. The solution tree analysis needs to be grounded and referenced from industry practices in addressing the specific problems relevant and applicable in context of Pakistan for further programming and policy insight. This approach will provide a clear visualization of causes, effects, and potential responses, thereby identifying gaps, trends, and reform opportunities to strengthen STEM education in Pakistan.

The scope of the study includes the following.

Scope:

A. Systematic Literature Review and Contextual Analysis

- Conduct an in-depth review of national and international reports, policies, and frameworks related to STEM education, including:
 - o National documents such as HEC policy guidelines and labor market assessments.
 - International benchmarks like the British Council's "Needs Analysis for STEM Higher Education in Pakistan" and case studies from countries such as South Korea, Finland, Singapore, and India (IITs).
- Identify relevant frameworks, success stories, and challenges in STEM education implementation.
- Map the alignment of Pakistan's STEM education with global trends and national development goals.

B. Stakeholder Mapping and Engagement

• Identify and engage key stakeholders, including:

- Students, faculty, and administrators from higher education institutions.
- o Industry representatives, employers, and policymakers.
- International and national development partners.
- Develop a stakeholder engagement plan to ensure meaningful participation and diverse perspectives.

C. Design and Validation of Research Instruments

- Develop research tools tailored to the study's objectives, including:
 - Surveys: For students, faculty, and employers to gather quantitative data on curriculum relevance, employability, and collaboration.
 - Key Informant Interview (KII) Guides: To capture detailed insights from policymakers, industry leaders, and university administrators.
 - Focus Group Discussion (FGD) Templates: For structured discussions among stakeholders on challenges and opportunities in STEM education.
- Pilot-test the instruments to ensure clarity, relevance, and reliability.
- Revise tools based on feedback to maximize their effectiveness.

D. Data Collection

- Utilize a mixed-methods approach for data collection:
 - o Quantitative Surveys:
 - Administer surveys to students and faculty members across universities, ensuring representation of public and private institutions and regional diversity.
 - Qualitative Data Collection:
 - Conduct at least 20 KIIs with key policymakers, employers, and academic leaders.
 - Organize 10–15 FGDs with diverse stakeholder groups, including industry experts and university representatives.
 - Collect secondary data from credible sources such as the Pakistan Bureau of Statistics, HEC, and labor market reports.

E. Analysis and Synthesis

- Apply advanced tools for data processing and analysis:
 - Quantitative Analysis: Use SPSS and Stata for descriptive and inferential statistics, including regression analysis to explore relationships between education quality and employability outcomes.
 - Qualitative Analysis: Use NVivo for thematic analysis to identify key themes and insights from KIIs and FGDs.
- Synthesize findings from primary and secondary data sources to present a comprehensive picture of STEM education.

F. Benchmarking and Gap Analysis

- Compare study findings with global best practices to establish benchmarks in curriculum design, faculty training, and industry collaboration.
- Conduct a detailed gap analysis to identify:
 - o Discrepancies between academic offerings and labor market needs.
 - o Barriers to employability, such as limited experiential learning and skill mismatches.
 - Shortcomings in infrastructure, faculty capacity, and institutional policies.

G. Stakeholder Validation and Workshops

- Organize workshops upon completion of the data collection to:
 - o Present preliminary findings and gather stakeholder feedback.

13 Evaluation Criteria

13.1 You will have your Proposal evaluated as set out below:

Stage 1: Proposals will be checked to ensure that they have been completed correctly and all necessary information has been provided. responses correctly completed with all relevant information being provided and all mandatory requirements as outlined in Section 8 met will proceed to Stage 2. Any Proposal not correctly completed in accordance with the requirements of this RFP and/or containing omissions may be rejected at this point. Where a Proposal is rejected at this point it will automatically be disqualified and will not be further evaluated.

Stage 2: If a bidder succeeds in passing Stages 1 of the evaluation, then it will have its Proposal evaluated in accordance with the evaluation methodology set out below.

13.2 <u>Award Criteria</u> – Responses from potential suppliers will be assessed to determine the most economically advantages proposal using the following criteria and weightings and will be assessed entirely on your response submitted:

13.3 <u>Scoring Model</u> – Proposals will be subject to an initial review at the start of Stage 2 of the evaluation process. Any Proposals not meeting mandatory requirements or constraints (if any) will be rejected in full at this point and will not be assessed or scored further. Proposals not so rejected will be scored by an evaluation panel appointed by the British Council for all criteria other than Commercial using the following scoring model:
