2 Introduction and Background to the Project / Programme

2.1 English as a Subject for Teachers and Educators (EaSTE II) is a professional development

course designed for teachers in Sindh's public schools to enhance the capacity of 30,000 newly

inducted Primary School Teachers (PSTs) and Early Childhood Teachers (ECTs) to effectively teach

English and other language subjects using inclusive and modern pedagogies at the primary level. The

teachers selected for this intervention are under 40 years of age, have passed an induction/selection

exam and have opted for in-service training in English, Urdu, or Sindhi.

The aims of the programme are to

- To enhance the capacity of 30,000 newly inducted Primary School teachers (PSTs) & Early Childhood Teachers (ECTs) in Sindh to effectively teach the English & other languages curriculum using modern and inclusive pedagogies (aligned with the Early Childhood Education and Foundational Learning Policy-2024), supported by 1000 mentors.
- To adapt the teaching pedagogies of other languages (Sindhi/Urdu) with English language teaching pedagogies to meet the needs of the students. Support multilingual pedagogy, recognizing local languages while strengthening teaching of English language as a core subjects.
- To Ensure sustainable improvement in inclusive, gender-sensitive teaching in the classroom. Ensure improvement in quality teaching and assessment of language.
- Integrate gender and inclusive approaches throughout all stages of the project with female teachers, minorities, and teachers with disabilities prioritized for EDI consideration.

The project uses a hybrid model where teachers follow five online self-access courses available on a Learning Management System (LMS). They do the courses at regular intervals outside school hours on the platform which is monitored. Their mentors receive the same training, so they are better able to support the teachers in the course. Each of the five modules takes four to six-weeks to complete and are spread over a period of two years, with each module running for three months in total. The course is in line with specific competencies built into the Sindh curriculum and the content is contextually relevant.

2.2 The purpose and scope of this RFP and supporting documents is to explain in further detail the requirements of the British Council and the process for submitting a proposal in response to this RFP ("**Proposal**").

3 Proposal Conditions and Contractual Requirements

This section of the RFP sets out the British Council's contracting requirements, general policy requirements, and the general conditions relating to this procurement process ("**Procurement Process**").

3.1 Contracting requirements

- 3.1.1 <u>Contracting authority</u>: the British Council which includes any other companies and organisations that control or are controlled by the British Council from time to time (see: http://www.britishcouncil.org/organisation/structure/status).
- 3.1.2 <u>Delivery location for goods and/or services</u>: The services will be required across Sindh, Pakistan.

- 3.1.3 <u>Duration</u>: 4 months with an option for an extension for up to 2 additional months based on performance.
- 3.1.4 Contractual terms: As_set out at Annex 1 (Terms and Conditions of Contract) ("Contract"). By submitting a Proposal, you are agreeing to be bound by the terms of this RFP and the Contract without further negotiation or amendment. In the event that the chosen service provider is operating as a Sole Trader or through a Personal Service Company, the British Council retain the right to issue specific contractual terms and conditions, in order to take account of this status. If you plan to submit a bid as a Sole Trader or Personal Service Company please contact moiz.khalid@britishcouncil.org for a copy of the specific terms. Once the Contract is awarded, there will be no changes allowed to the Contract (except in accordance with the provisions of the Contract). Any clarification questions in relation to any aspect of this Procurement Process and the associated documentation should be submitted in accordance with the process set out in paragraph 12 (Clarification Requests). Only changes which relate to the correction of ambiguity or manifest error in relation to the terms of the Contract will be considered and, if necessary, the British Council may, when issuing its response to clarification questions, reissue Annex 1 to reflect such changes. Any proposed amendments received from a potential supplier as part of its Proposal shall entitle the British Council to reject that Proposal and to disqualify that potential supplier from this Procurement Process.

3.2 General Policy Requirements

Accordingly, Proposals should be made on the basis of and strictly in accordance with the requirements of this RFP.
- 3.3.2 <u>Third party verifications</u> Your Proposal is submitted on the basis that you consent to the British Council carrying out all necessary actions to verify the information that you have provided, and the analysis of your Proposal being undertaken by one or more third parties commissioned by the British Council for such purposes.
- 3.3.3 <u>Information provided to potential suppliers</u> Information that is supplied as part of this Procurement Process is supplied in good faith. The information contained in the RFP and the supporting

documents and in any related written or oral communication is believed to be correct at the time of issue. No liability (save for fraudulent misrepresentation) is accepted for its accuracy, adequacy or completeness and no warranty is given as such.

- 3.3.4 <u>Potential suppliers to make their own enquires</u> You are responsible for analysing and reviewing all information provided to you as part of this Procurement Process and for forming your own opinions and seeking advice as you consider appropriate. The clarification process set out in paragraph 12 should be used for any queries in relation to this Procurement Process.
- 3.3.5 <u>Amendments to the RFP</u> At any time prior to the Response Deadline, the British Council may amend the RFP and if appropriate, the Response Deadline shall, at the discretion of the British Council, be extended.
- 3.3.6 <u>Compliance of Proposal</u> Any goods and/or services offered should be on the basis of and strictly in accordance with the RFP (including, without limitation, any specification of the British Council's requirements, these Proposal Conditions and the Contract) and all other documents and any clarifications or updates issued by the British Council as part of this Procurement Process.
- 3.3.7 <u>Compliance with the terms of the Contract</u> The successful supplier must comply with the Contract as set out in Annex 1 without any amendment (save as described in paragraph 3.1.4).
- 3.3.8 <u>Format of Proposal</u> Proposals must comprise the relevant documents as detailed by the British Council in Annex 2 (Supplier Proposal) completed in accordance with relevant all instructions. Any documents requested by the British Council must be completed in full. It is important that you read the RFP carefully before completing and submitting your Proposal.
- 3.3.9 <u>Modifications to Proposals once submitted</u> You may modify your Proposal prior to the Response Deadline by giving written notice to the British Council. Any modification should be clear and submitted as a completely new Proposal in accordance with Annex 2 (Supplier Proposal) and these Proposal Conditions.
- 3.3.10 <u>Disqualification</u> If you breach these Proposal Conditions, if there are any errors, omissions or material adverse changes relating to any information supplied by you at any stage in this Procurement Process, if any other circumstances set out in this RFP, and/or in any supporting documents, entitling the British Council to reject a Proposal apply and/or if you or your appointed advisers attempt:
 - to inappropriately influence this Procurement Process or fix or set the price for goods or services;
 - to enter into an arrangement with any other party that such party shall refrain from submitting a Proposal;
 - to enter into any arrangement with any other party (other than another party that forms part of your consortium bid or is your proposed sub-contractor) as to the prices submitted;
 - to collude in any other way;

- to engage in direct or indirect bribery or canvassing by you or your appointed advisers in relation to this Procurement Process; or
- to obtain information from any of the employees, agents or advisors of the British Council concerning this Procurement Process (other than as set out in these Proposal Conditions) or from another potential supplier or another Proposal,

the British Council shall be entitled to reject your Proposal in full and to disqualify you from this Procurement Process. Subject to paragraph 3.3.1 below, by participating in this Procurement Process you accept that the British Council shall have no liability to a disqualified potential supplier in these circumstances.

- 3.3.11 <u>Proposal costs</u> You are responsible for obtaining all information necessary for preparation of your Proposal and for all costs and expenses incurred in preparation of the Proposal. Subject to the "Liability" Tender Condition below, you accept by your participation in this Procurement Process, including without limitation the submission of a Proposal, that you will not be entitled to claim from the British Council any costs, expenses or liabilities that you may incur in submitting a Proposal irrespective of whether or not your Proposal is successful.
- 3.3.12 Rights to cancel or vary this Procurement Process Nothing in this Procurement Process will bind the British Council to enter into any contractual or other arrangement with you or any other potential supplier. It is intended that the remainder of this Procurement Process will take place in accordance with the provisions of this RFP, but the British Council reserves the right to terminate, amend or vary (to include, without limitation, in relation to any timescales or deadlines) this Procurement Process by notice in writing. Subject to the "Liability" Tender Condition below, the British will have no liability for any losses, costs or expenses you incur as a result of such actions.
- 3.3.13 <u>Consortium Members and sub-contractors</u> It is your responsibility to ensure that any staff, consortium members, sub-contractors and advisers abide by these Proposal Conditions and the requirements of this RFP.
- 3.3.14 <u>Liability</u> Nothing in these Proposal Conditions is intended to exclude or limit the liability of the British Council in relation to fraud or in other circumstances where the British Council's liability may not be limited under any applicable law.

4 Confidentiality and Information Governance

4.1 All information supplied to you by the British Council, including this RFP and all other documents relating to this Procurement Process, either in writing or orally, must be treated in confidence and not disclosed to any third party (save to your professional advisers, consortium members and/or subcontractors strictly for the purposes only of helping you to participate in this Procurement Process and/or

prepare your Proposal) unless the information is already in the public domain or is required to be disclosed under any applicable laws.

- 4.2 You shall not disclose, copy or reproduce any of the information supplied to you as part of this Procurement Process other than for the purposes of preparing and submitting a Proposal. There must be no publicity by you regarding the Procurement Process or the future award of any contract unless the British Council has given express written consent to the relevant communication.
- 4.3 The British Council reserves the right to disclose all documents relating to this Procurement Process, including without limitation your Proposal, to any employee, third party agent, adviser or other third party involved in the Procurement Process in support of, and/or in collaboration with, the British Council. The British Council further reserves the right to publish the Contract once awarded and/or disclose information in connection with supplier performance under the Contract in accordance with any public sector transparency policies (as referred to below). By participating in this Procurement Process, you agree to such disclosure and/or publication by the British Council in accordance with such rights reserved by it under this paragraph.
- 4.4 The Freedom of Information Act 2000 ("FOIA"), EU General Data Protection Regulation (GDPR) 2015, the Environmental Information Regulations 2004 ("EIR"), and public sector transparency policies apply to the British Council (together the "**Disclosure Obligations**").

5 Proposal Validity

5.1 Your Proposal must remain open for acceptance by the British Council for a period of sixty days from the Response Deadline. A Proposal not valid for this period may be rejected by the British Council.

6 Payment and Invoicing

- 6.1 The British Council will pay correctly addressed and undisputed invoices within 30 days in accordance with the requirements of the Contract. Suppliers to the British Council must ensure comparable payment provisions apply to the payment of their sub-contractors and the sub-contractors of their sub-contractors. General requirements for an invoice for the British Council include:

7 Specification

Objectives

British Council is seeking an experienced agency to conduct a thorough baseline study with an integrated needs assessment in Sindh to identify the state of:

- Pedagogical practices relating to English (as well as Sindhi and Urdu) among early childhood and primary teachers, including gaps in their key competencies, especially those relevant to EaSTE II, as well as gaps in subject knowledge, use of inclusive strategies, and access to professional development services.
- The state of (baseline level) of learner's performance/participation and engagement in English (and other language subjects) refer the outcomes and sub indicators for detail below
- How are CPD practices perceived in terms of equity, inclusion, recognition, and support for career progression? (being relevant, context specific, embodying contemporary practices, able to help in addressing in ground gaps on pedagogy) plus any prospective benefits
- To what extent are the existing systems, policies, and digital tools aligned with and supportive of the Sindh CPD Model (2022) for effective teacher professional development and institutional ownership? (CPD for ECE and primary level)

The programme embodies the following set of outcomes:

- 1. Improved classroom practice among early-childhood and primary-level teachers through enhanced language pedagogy and subject knowledge.
- 2. Strengthened capacity of 1,000 mentors to provide ongoing academic and pedagogical support to teachers.
- 3. Increased use of inclusive, gender-sensitive, and multilingual teaching strategies in language classrooms.
- 4. Better alignment of teacher professional development with the Sindh CPD Model (2022) for ECE and primary level.
- 5. Enhanced learner outcomes in English and other language subjects across approximately 2 million children in public primary schools.
- 6. Greater institutional ownership of CPD practices within SELD and increased use of digital tools for teacher development.
- 7. Recognition of CPD participation through credit hours that support teacher promotion and career progression.
- 8. Promotion of equity, diversity, and inclusion by prioritising female teachers, minorities, and teachers with disabilities.

Against each of the outcome area we have lined some specific measurable sub-indicators to track the currently state of affair at the baseline stage. However, the agency is expected to review use/tweak and add to these sub-indicators and agree on a common frame before proceeding to instrumentation. The

agreed frame will then be subsequently used for building the formative assessments data as well as for endline. The detailed list of indicator framework will be provided in the inception stage

At the proposal stage, the agency is expected to come-up with a detailed plan for conducting a thorough baseline-cum-needs assessment study across all the divisions of Sindh, marking the above-mentioned questions as yardstick. The plan should include a well-structured sampling and methods framework that ensures coverage across all divisions of Sindh. It should outline the selection of a representative set of districts, schools, and teachers through a multi-cluster approach, guided by clearly defined criteria and rationale. The specifics are as follows:

Note: the agency may adopt hybrid model for collecting data where possible and circumstances allow, without affecting the quality.

Target population:

- ➤ Layer I: teacher educators (here referred as mentors 1,000 direct beneficiaries),
- ➤ Layer II: Primary teachers (30,000 as direct beneficiaries)
- Layer III: learners (approx. 2M -indirect beneficiaries),

This should also involve stakeholders within SELD and the wider education department. Given the discrete set of target beneficiary groups, the sampling needs to be appropriately segregated to reflect these distinctions.

- Geographic scope: Focus all divisions of Sindh and selected a representative sample of districts based on a sound criteria and schools across the province.
- Data collection methods: Mixed methods; surveys, classroom observations (of selected number of schools), focus group discussions (FGDs) if deemed appropriate, key informant interviews (KIIs), and review of institutional documents.

Note: based on the proposed sample by the agency, the specific list of schools and teachers as well as stakeholder will be provided by the government department.

• Key data desegregation cuts required: disaggregation by gender, disability, minority status and urban-rural divide.

Key Deliverables

- 1. Inception Report: Including the revised indicator framework, detailed methodology, and finalised data collection tools.
- 2. Validation Workshop: to conduct upon completion of data collection, with the British Council, to review preliminary findings and ensure accuracy, contextual relevance, and stakeholder buy-in. For this the agency need to prepare a slide with key findings and data on the questions and state of teachers on each competency area.

- 3. Baseline and Needs Assessment Report: Draft and final versions (at least 2 iterations of review), with disaggregated findings, prepared in the agreed format with the British Council.
- 4. Presentation of the key findings: PowerPoint summary highlighting key results and insights.

11.2 The following requirements should be complied with when submitting your Proposal in response to this RFP:

- Please ensure that you send your submission in good time to prevent issues with technology –
 late Proposals may be rejected by the British Council.
- Do not submit any additional supporting documentation with your Proposal except where specifically requested to do so. PDF, JPG, PPT, Word and Excel formats can be used for any additional supporting documentation (other formats should not be used without the prior written approval of the British Council).
- All attachments/supporting documentation should be provided separately to your main Proposal document, clearly labelled and cross-referenced to the Proposal as relevant.
- If you submit a generic policy / document you must indicate the page and paragraph reference that is relevant to a particular part of your Proposal.

- 12.2 Any clarification requests should clearly reference the appropriate paragraph in the RFP documentation and, to the extent possible, should be aggregated rather than sent individually.
- 12.3 The British Council reserves the right to issue any clarification request made by you, and the response, to all potential suppliers unless you expressly require it to be kept confidential at the time the request is made. If the British Council considers the contents of the request not to be confidential, it will inform you and you will have the opportunity to withdraw the clarification query prior to the British Council responding to all potential suppliers.
- 12.4 The British Council may at any time request further information from potential suppliers to verify or clarify any aspects of their Proposal or other information they may have provided. Should you not provide supplementary information or clarifications to the British Council by any deadline notified to you, your Proposal may be rejected in full, and you may be disgualified from this Procurement Process.

13 Evaluation Criteria

13.1 You will have your Proposal evaluated as set out below:

Stage 1: Proposals will be checked to ensure that they have been completed correctly and all necessary information has been provided. responses correctly completed with all relevant information being provided and all mandatory requirements as outlined in Section 8 met will proceed to Stage 2. Any Proposal not correctly completed in accordance with the requirements of this RFP and/or containing omissions may be rejected at this point. Where a Proposal is rejected at this point it will automatically be disqualified and will not be further evaluated.

Stage 2: If a bidder succeeds in passing Stages 1 of the evaluation, then it will have its Proposal evaluated in accordance with the evaluation methodology set out below.

13.2 <u>Award Criteria</u> – Responses from potential suppliers will be assessed to determine the most economically advantages proposal using the following criteria and weightings and will be assessed entirely on your response submitted:

13.3 <u>Scoring Model</u> – Proposals will be subject to an initial review at the start of Stage 2 of the evaluation process. Any Proposals not meeting mandatory requirements or constraints (if any) will be rejected in full at this point and will not be assessed or scored further. Proposals not so rejected will be

scored by an evaluation panel appointed by the British Council for all criteria other than Commercial using the following scoring model:

13.4 <u>Commercial Evaluation</u> – Your "Overall Price" (as calculated in accordance with requirements of Annex 3 (Pricing Approach) for the goods and/or services will be evaluated by the evaluation panel for the purposes of the commercial evaluation, further information on this approach may be available in Annex 3. In the event that any prices are expressed as being subject to any pricing assumptions, qualifications or indexation not provided for by the British Council as part of the pricing approach, the British Council may reject the full Proposal at this point. The British Council may also reject any Proposal where the Overall Price for the goods and/or services is considered by the British Council to be abnormally low following the relevant processes set out under the procurement rules. A maximum offer

score of 10 will be awarded to the Proposal offering the lowest "Overall Price". Other Proposals will be

awarded a mark by application of the following formula: (Lowest Overall Price/Overall Price being

evaluated) x 10 (rounded to two decimal places) = commercial score.

13.5 Moderation and application of weightings – The evaluation panel appointed for this Procurement

Process will meet to agree and moderate scores for each award criteria. Final scores in terms of a

percentage of the overall Proposal score will be obtained by applying the relevant weighting factors set

out as part of the award criteria table above. The percentage scores for each award criteria will be

amalgamated to give a percentage score out of 100.

13.6 The Winning Proposal(s) - The winning Proposal shall be the Proposal scoring the highest

percentage score out of 100 when applying the above evaluation methodology, which is also supported

by any required verification evidence (to include, without limitation, any updated information)] obtained

by the Authority relating to any self-certification or other requirements referred to at any time in this

Procurement Process.
