The work includes constructing a central acoustic partition, installing sound sealed doors, improving ceiling wall insulation and electrical setups for each room. Once completed both rooms will function as independent, quiet and acoustically controlled environments suitable for high quality speaking assessments.

(b) renovating external courtyard washrooms which require complete demolition and restoration. The goal is to create brand new washrooms as per the approved design. All fittings and accessories to be used are to be new, genuine and of high quality as per the BOQ.
